1. WATER PLANT REPORT: William present. Reported that Todd with Atoka 1 Water District (Wardville) got leaks fixed. The water tower is at 88 feet today. Roy Blanks came down and repaired South sewer lagoon, 48 foot of pipe. The town paid for the parts and he will charge for labor. Leak on 6th and Grand that we will repair this weekend. Everyone should have water

- including Rural Water 11 and Wardville. Deanna informed him that Rebecca Cox called today and doesn't have water, but is not home. William stated he will check it out.
- 2. Discussion and possible approval for Flo Elliot to move a Mobile Home in at Lot 2, Block 60 on South Polk Street and hook-up water and sewer. Flo is present and provided Mobile Home permit with pictures. Discussed the mobile home and she stated it may be a month before she can move it in due to the ground being wet. Discussed purchase of the permit and Sewer tap, there is a water meter there.
