CALL MEETING TO ORDER: Mayor Naugle called the meeting to order at 6:36 p.m.

CONSIDERATION OF THE MINUTES: Board members reviewed the minutes. No questions. Mayor Naugle made the motion to approve the minutes, seconded by K. Sexton. K. Sexton-yes, Kristi Hall-yes, Kari Peterson- yes, Ned Naugle- yes. Motion carried.

APPROVAL OF FIANCIAL REPORT: Board members reviewed Financial Report. Jerri Ellis reported an Income of \$146,461.05, Expenses of \$87,859.57 with a Net Income of \$58,601.48. No questions. Mayor Naugle made the motion to approve the Financial Report, seconded by K. Peterson. K. Sexton-yes, Kristi Hall-yes, Kari Peterson- yes, Ned Naugle- yes. Motion carried.

APPROVAL OF PURCHASE ORDERS: Board members reviewed Purchase Orders. No questions. Mayor Naugle made the motion to approve the Purchase Orders, seconded by K. Sexton. K. Sexton-yes, Kristi Hall-yes, Kari Peterson- yes, Ned Naugle- yes. Motion carried.

Discussion of having a special meeting to revisit this agenda item, Deanna stated that if the Chief makes the decision that there doesn't need to be a special meeting on April 14th. No Vote with agreement from Pat Layden.
