CALL MEETING TO ORDER: Mayor Johnston called the meeting to order at 8:00 p.m.

APPROVAL OF PURCHASE ORDERS: D. Sexton presented 2 additional purchase orders number GF 5979 to VSP in the amount of \$32.96 and GF 5980 to Trevor Stokes in the amount of \$700.00. - 7. Discussion and possible approval for a Mutual Aid Agreement with Pittsburg County Sherriff's Office. Mayor Johnston made the motion to do a Resolution from Title 11 pursuant to law enforcement assistance, seconded by Naugle. K.Sexton, Naugle, Johnston, VanBlaricom, Ramey all voted yes. Motion carried.
- 8. Discussion and possible approval of Jail Agreement with Pittsburg County Sherriff's Office. Motion made by Mayor Johnston to approve the workshop, motel not to exceed \$450.00 plus per diem, seconded by Naugle. K. Sexton, Naugle, Johnston, VanBlaricom, Ramey all voted yes. Motion carried.
- 15. Discussion and possible approval for the Evidence Tech from Oklahoma County Sherriff's office to assist Jess with Evidence Room. Jess discussed the possibility of the Technician from Oklahoma City Police Department coming to assist him with cleaning and organizing the evidence room.
